

**MENDOCINO COUNTY EMPLOYERS RESPOND TO BUSINESS CONDITIONS SURVEY**

To ring in the New Year, the Employers Council of Mendocino County (ECMC) initiated a countywide business conditions survey to prepare this Business Conditions Survey Report for 2012.

The survey and this report had two objectives. The first objective was to grant businesses the opportunity to share how they performed in 2011 and what their performance and hiring projections will be for 2012. The second objective was to capture that information in an anonymous format to share it in a report to the community.

With assistance from the North Coast Builders Exchange, the Mendocino County Farm Bureau, and

various other business organizations, the survey was successfully circulated from coast to inland, North to South Mendocino County. Over 100 businesses responded to the survey, and a summary of their responses are provided within this report.

In addition to questions about business conditions and confidence, each business was granted the opportunity to share their opinion about what could be done locally to improve business conditions and employment opportunities.

The Employers Council sincerely appreciates the time and effort of all the business organizations and the businesses who took the time to make this report possible.

**Economic Development Actions:**

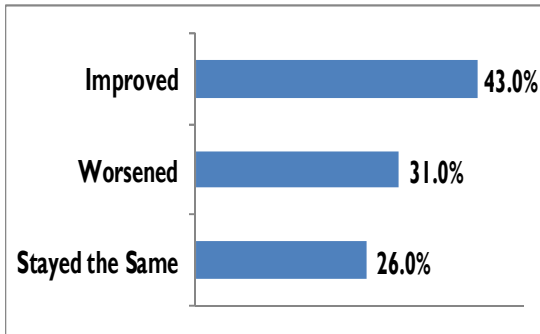
- Business Expansion is a focused effort to help local business to become more competitive and profitable to add jobs.

Over 80 employers responded to the optional survey question: Any comments you wish to provide about local business conditions? Here’s a sample of what they said:

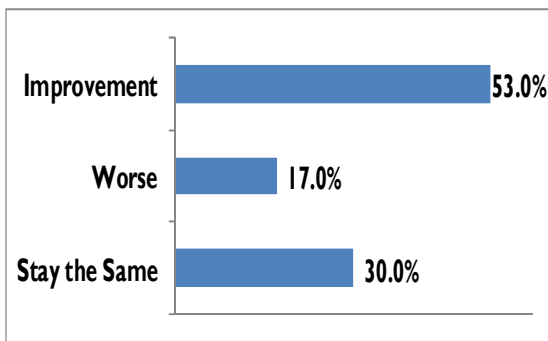
“In our 35 years of business in Mendocino County we have been through several downturns in the National economy. This one has been the very worst.” “People are still not making major investments, but maintaining their existing infrastructure.” “...it is tough to see so many businesses struggle during these times...” “We need clean industries and more jobs.” “[We are] very dependent on visitors from outside the area” “Find ways to make things happen rather than discourage things.” “County and City need to streamline their processes and assist business...” “There does not seem to be any support from local government to really encourage development and business/economic growth.” “We are happy to be surviving and hopeful that the future will be stronger.”

**How did your business' condition in 2011 compare with 2010?**



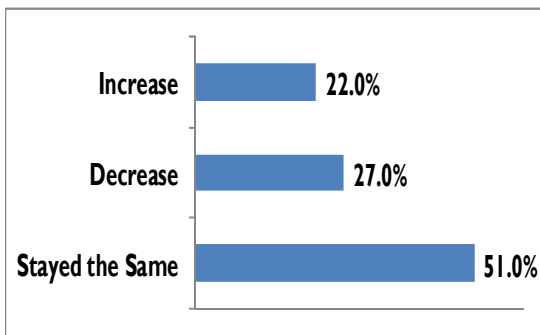
*"Tourists came in the summer but didn't spend much"*

**Over the course of this year (2012) how are you anticipating your business' condition to be?**



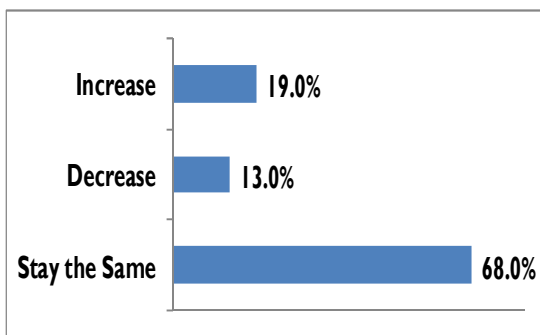
*"...we work in the timber industry which continues to decline..."*

**During 2011, Did Hiring?**



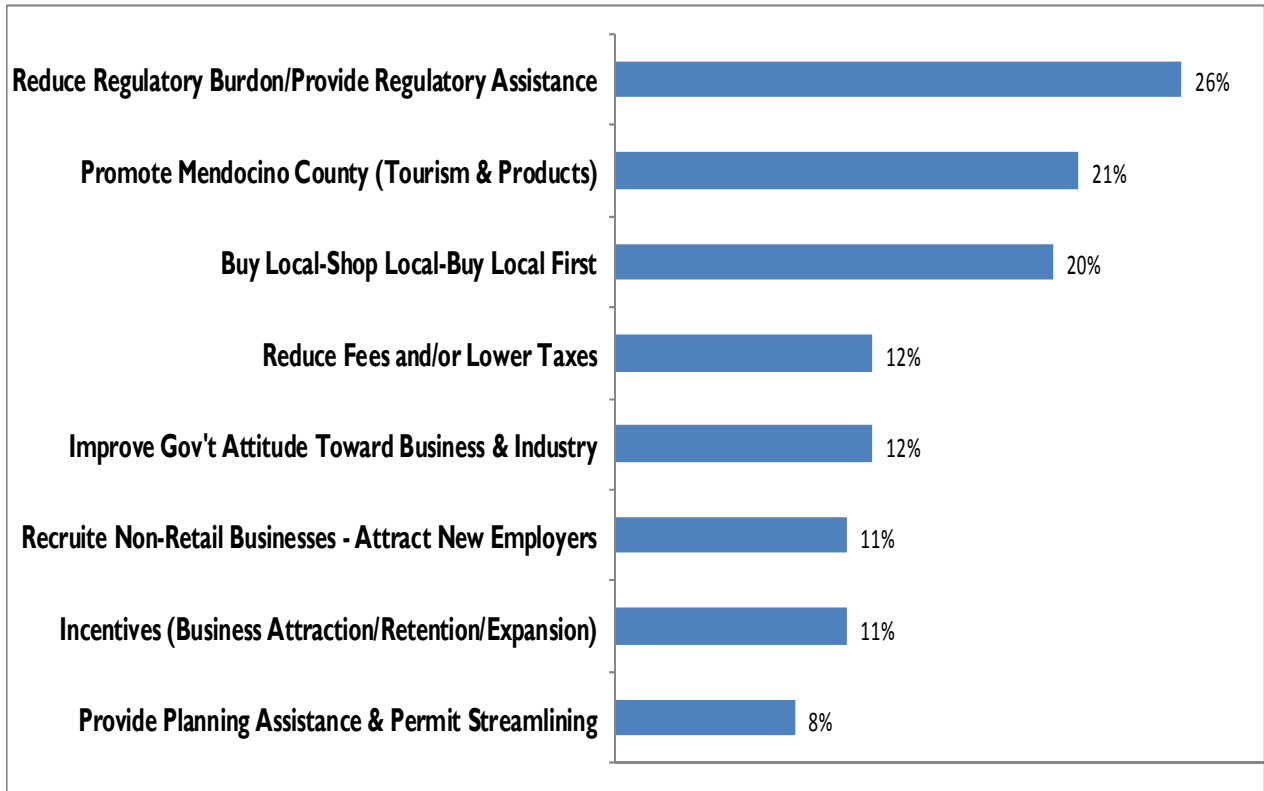
*"...about 10% more hours of work."*

**In this year, 2012, your hiring will:**

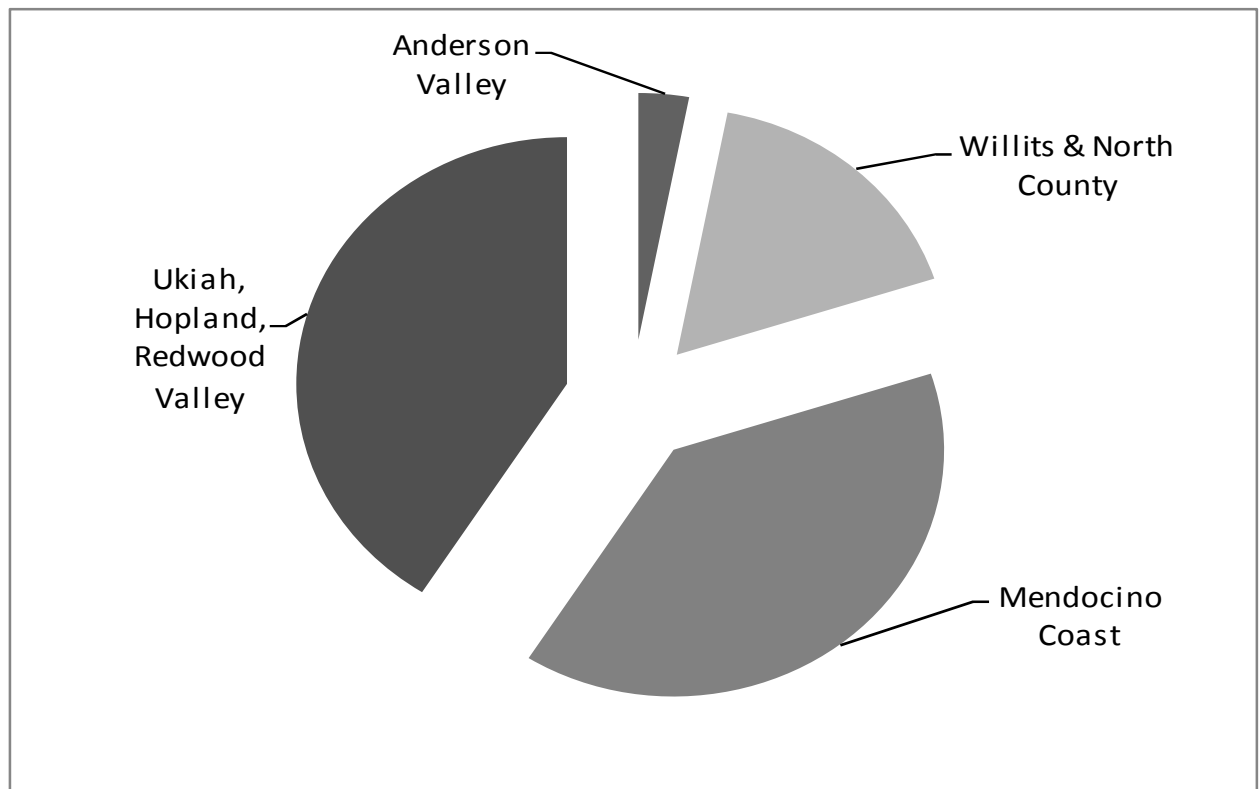


*"No change in staff numbers."*

**About ECMC:**

The Employers Council of Mendocino County is a professionally managed non-profit membership based trade association. **Survey Methodology**

The methods used to prepare this report started with the use of a web based survey tool. The Employers Council of Mendocino County (ECMC) wrote the survey questions and then invited Mendocino County area businesses to participate in the survey on the basis of a first come first served process. Invitations to participate in the survey were offered and distributed by several sources, mostly by email communication. The survey was purposely designed to permit respondents to remain anonymous but captured zip code information to allow for the elimination of responses from any non-Mendocino county area businesses. Zip code information was also captured and presented in this report to show the final geographic distribution of participating businesses. Multiple choice questions were automatically tabulated by the on-line survey provider and written responses were manually tabulated by ECMC using a key-word and/or key-term process. The information contained in this report was compiled by capturing the responses, views and opinions from the first 100 private sector businesses who successfully completed the survey.
